4. Business Arising

5. President's Address - M. Trumpour

Thanks to members for their support. Thanks also to the trustees who contribute their time and talents.

There are four Trustees who have stepped down.

- 1. Les O'Connor has been the President of the Toronto Chapter. The President is now Deirdre Keleher.
- 2. Leslie Cowger has been part of the Administrative Team and has been very involved, including today.
- 3. Rick Moran has been chair of the Bylaw Review and will continue to work on this as a volunteer.
- 4. Kerry Muhlestein has been a hard-working and valuable Vice- President for many years.

Special thanks also to NMC for always having a place for us to meet and have an office. We have had a 53 year association with NMC.

Challenges

- through COVID
- The Ontario Government enacted new legislation for all Not-For-Profit organizations. There was a review of the Articles of Incorporation and a template into which our Bylaws had to fit. Thanks to Rick Moran and Paul English for spearheading this.
- We have a shrinking academic base. The Calgary Chapter has especially shrunk over the last 5 years.
- Dr. Wegner of NMC has been on a medical leave recently. One professor at NMC has not been replaced.
- We have tried to forge a new relationship between NMC and TMU. We had a TMU intern working with us this past spring.
- The organization Saving Ancient Studies Alliance (SASA) has contacted us. We may find out more about this as a need to encourage interest in history.

We have pared down the number of Journals in the office and given some extras to the NMC library.

Some very old material, Volumes 1-5 of the JSSEA, have now been put online. Thanks to P. Robinson for improving the Website.

Thanks to the editors, Volume 49 of the JSSEA was ready earlier than expected and is available for pick-up this weekend.

We had an excellent speaker for the Sally Katary Travel Scholarship Fund, Mohamed Ismail Khaled. Narasim Katary donated a further \$20,000 to us. We have not had a good financial return on the earlier \$10,000 invested at TD, so are investing the new donation differently.

Accessing the Steven Shubert inheritance has been a long, ongoing process.

Next Year

Administration is difficult to run and 4 trustees (G. Gibson, L. Cowger, A. Londes, E. Crabtree) have been assisting M. Trumpour. This may not be sustainable and we may need to consider hiring some paid support.

6. Treasurer's Report - A. Londes, with M. Trumpour explaining some items

Our accountant, RSP Accountants, is paid each year to go over our finances and they submit a report. Their 2022-23 Financial Report was presented to the Membership and is appended at Attachment 1. The Report covers the entire organization, both National and Chapters.

Unlike the accountant's report, the National budget does not include the Chapters. It is appended as Attachment 2. M. Trumpour noted that Donations are to be used for charitable purposes. Because some of the donations are targeted for specific purposes, the Budget can appear distorted. E.g., looking at the figures in the Cash Balances table, we need to subtract \$20000 which is for the Sally Katary Lecture Fund. In addition,

donations to the Tod Temple Project (C. Kirkpatrick, Director) are not really ours, but are reserved for that project.

There was a discussion re: the Cash Balances table.

TD has notified us that they will be no longer working with funds for organizations like ours; therefore, a new way for us to invest must be found.

We raised \$2000 from a University in Japan which ordered all copies of the JSSEA.

Chapter Reports

a) Calgary P. English

The Calgary Chapter has been largely inactive since the Covid pandemic, except for an occasional newsletter mainly promoting online Egyptological events.

The Chapter executive has been discussing potential ways to reactivate the Chapter and our next step is to hold a brainstorming and planning session, preferably before the end of November if scheduling allows.

No decision has been made yet, but one likely scenario is to schedule at least one or two in-person meetings which will help assess interest in proceeding further.

It is possible that these, and most of any future talks, will involve presenters attending virtually.

The Chapter finished the year in good financial standing with \$5,254.01 in General Funds, \$2,520.32 in our Speakers Fund, and \$2044.81 in our Millet Award Fund.

Our priorities for this year include attempting to increase our membership numbers. Our first effort at this was to have a physical mailing in September, rather than only an emailing. We would also like to have more social events this year to help members reconnect. We are hoping that this will also help new members to feel more welcome. To that end, we held our first social event in September. There was a short 30 minute lecture about the senet board in the Royal Ontario Museum. Dakhleh Oasis Project

2022 - 2023 Field Season

A Brief Report to the SSEA Annual Meeting, November 3, 2023.

The 45th season of the original Dakhleh Oasis Project did not take place because of lack of permission and the Covid 19 pandemic. The dig house was visited by former director Tony Mills but no field work was done.

However, DOP member Peter Sheldrick was invited to participate in the Amheida Project, conducted by the New York University group. Their success in getting permission has given new hope and impetus for future DOP work.

The Tenth International Conference of the Dakhleh Oasis Project, hosted by the British Museum September 7 & 8, 2023, was very successful and well attended.

The Dakhleh Oasis Project has expanded since it was instigated as a concession granted to the SSEA. The Project is still very much alive and applications and planning for the new season are under way. These include reopening the 'Ain Birbiyya temple excavations, further studies of preserved bodies from Kellis 2, continued excavations at the Mut el Kharab temple enclosure, further rock art research, a possible new leader for late Prehistory studies and more.

Tod Temple Project

2022 - 2023 Field Season

A Brief Report to the SSEA Annual Meeting

The Tod Temple Project was established this year under the auspices of the SSEA, and the University of Western Ontario, and in cooperation with the Egyptian Ministry of

Tourism and Antiquities. The goal of this project is to provide urgent conservation interventions at the Temple of El-Tod, which was named in the Egyptian Ministry of Tourism and Antiquities' Updated List of Priorities for Archaeological Work 2022-2023.

Fieldwork was completed from Dec 24, 2022 to April 13, 2023. Casey Kirkpatrick and Fathy Yaseen directed the work and C. Kirkpatrick made two trips to Egypt from Germany for the project. Special thanks are given to the project's reises, Mohamed El-Azeb Hakim and Ali Hassan Ibrahim, as well as the reis for stone movement Mohamed Ali Ghussob, for their excellent work. Our sincere gratitude is also given to Dr. Moustafa Waziri, Dr. Fathy Yaseen, and the many esteemed people in the Egyptian Ministry of Tourism and Antiquities that approved and supported the Tod Temple Project.

During this field season, a new display platform was built at the site and 22 decorated sandstone temple blocks and fragments were restored, rejoined where possible, and moved onto this platform to reverse, and prevent further destructive effects from their contact with groundwater, salts, and plants. The site was also secured through the reconstruction of parts of the site's surrounding security wall and efforts were made to remove the excessive plant growth in the area of the sacred lake.

A preliminary report on this site and the work of the Tod Temple Project can be found in the SSEA Spring 2023 Newsletter and another publication is forthcoming. Further information about the project and fundraising details can be found on the SSEA website.

It might be possible for the Chapter officers and selected others to be able to access some of the data, for example to send out renewal emails and letters, or advising people of specific local events, etc. But that is something that I will be looking at on my return to Europe.

As we hinted at last year, and Mark mentioned earlier, the ZEFFY system might help improve the processing of payments via the website. But I don't have much knowledge of the system myself, not being Canadian nor based in Canada... but... watch this space.

We might also be able to do some redesign of the website over the next few months or so, so I foresee some interesting developments on the horizon.

I must thank everyone who has helped so far in building up the website with either sending in contributions, or helping to update or edit the site with me. Keep all your contributions and suggestions coming and look out for changes.
